STEP 1 OF 4

Clean the area where the ProClip will attach. The adhesive tape cover must be removed.

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position / the P in ProClip is at the top.

Hook the grooved lower edge of the ProClip over the frame surrounding the air vent.



STEP 2 OF 4

Press the upper part of the ProClip forward so the grooved edge hooks under the frame surrounding the air vent.



STEP 3 OF 4

The ProClip is in place.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 4 OF 4

The ProClip is in place.
