GAP OPENER

STEP 1 OF 4

Clean the area where the ProClip will attach. The adhesive tape cover must be removed.

Press the thin end of the enclosed gap opener into the gap between the climate control panel and the padded dash above the panel, to widen the gap.



STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position / the P in ProClip is at the top. Then press the lower edge of the ProClip into the seam next to the gap opener.



STEP 3 OF 4

Press forward on the top edge of the ProClip and hook the thin top edge into the seam between the display and frame around the display.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 4 OF 4

The ProClip is in place.
