### **STEP 1 OF 4**

# Installing the Mount:

This mount can be installed over either of the vents under the center screen.

Hold the mount with the ProClip USA sticker on top.

There is a seam at the bottom of the vent; between the outer housing and the inner flashing of the vent. Insert the bottom lip of the mount into this seam.



# **STEP 2 OF 4**

# Inserting the upper lip:

Use your thumbs to press down on the top of the mount and slip it under the edge of the screen.



## **STEP 3 OF 4**

There is a seam just behind the plastic trim that surrounds the display. The mount should click into that seam.

If the mount is going to far inwards; you may have missed the seam. If this happens gently pull it back towards you until it clicks into place.



**STEP 4 OF 4** 

The ProClip is in place.
