## STEP 1 OF 4

### **Installing the Mount:**

Clean the area where the ProClip will attach. The adhesive tape cover must be removed.

There is a piece of trim that wraps around the center screen. The first seam is under this trim. Insert the included gap openers as shown.



## STEP 2 OF 4

### **Insert the Lower Lip:**

Hold the mount so the ProClip sticker is facing the windshield.

Insert the lower lip of the mount into the open seam from step 1.



## STEP 3 OF 4

### **Move the Gap Openers:**

Remove the gap openers from step 1.

Re-insert the gap openers as shown. Make sure they will not be in the way of the mount for step 4.



## **STEP 4 OF 4**

### **Insert the Final Lip:**

Using your thumb, press the face of the mount so the upper lip snaps into the seam.

After the mount snaps into the seam, remove the gap openers.
