## STEP 1 OF 6

### **Installing the Lower Lip:**

The first seam is between the hard plastic around the vent and the soft trim just above the vent.

Insert the included Gap Opener into the seam to open it.



## **STEP 2 OF 6**

### **Installing the Lower Lip:**

Insert the lower lip into the seam from Step 1.

With the lower lip in place, remove the Gap Opener.



## STEP 3 OF 6

### **Installing the Upper Lip:**

Insert the Gap Opener into the upper seam.

This seam is between the soft top layer of the dash and the hard layer just underneath. See Step 4 for an example photo.



## **STEP 4 OF 6**

### **Example photo of the correct seam.**

In this photo you can see the separation between the soft top layer of the dash and the hard layer underneath. The mount will hook onto the top layer.

## STEP 5 OF 6

### **Installing the Upper Lip:**

Push on the face plate using your thumb until the mount hooks itself into the seam from Step 4.

Remove the Gap Opener.



## **STEP 6 OF 6**

**The ProClip is in place.**
