STEP 1 OF 4

Installing the Lower Lip:

Clean the area where the ProClip will attach. The adhesive tape cover must be removed.

The first seam is under the vent housing, between the trim under the vents and the trim around the climate controls. Insert the lower lip into this seam and rotate the mount upwards so the lip fits behind the trim.



STEP 2 OF 4

Installing the Upper Lip:

The silver trim above the vents is where the second seam is located. Insert the included gap openers into the seam between the silver trim and the vent.



STEP 3 OF 4

Installing the Upper Lip:

Fit the upper lip into the opened seam. You may need to press down on the top of the mount to get the lip under the silver trim.



STEP 4 OF 4

Remove the Gap Openers:

The ProClip is in place.
