## **STEP 1 OF 4**

### **Finding the desired location for mount:**

Place the mount in your desired location. It can be installed above either the left or right center vent in the parallel seams. (upper vent seam & upper dash seam) See the picture above.



## **STEP 2 OF 4**

### **Installing the First Lip:**

Gently clean the area where the mount will attach. Remove the adhesive tape cover.

Insert the two supplied gap openers into the upper dash seam on both sides of the mount. (See the picture above)



## **STEP 3 OF 4**

### **Installing the First Lip:**

Gently press the thin angled lip down into the upper dash seam.



## **STEP 4 OF 4**

### **Installing the Second Lip:**

Gently pull the mount toward you with even outward pressure. That will flex the mount into the top of the vent seam. See the picture above.

## Returns
